HOW DOES IT WORK?

- 1 INQUIRE ABOUT YOUR OPTIONS**

- 2 SUBMIT SUPPORTING DOCUMENTATION**
Forward the most recent royalty statements along with any relevant supporting documents such as leases, deeds, and division orders for the past few months.
- 3 GIFT REVIEW AND ACCEPTANCE**
We will review and appraise the rights/royalties for gift acceptance.
- 4 SIGN PAPERWORK, RECEIVE A CHARITABLE INCOME TAX DEDUCTION, AND MAKE AN IMPACT!**

GIFT OPTIONS

You can give oil, gas or mineral rights directly to Cru or into a Cru Foundation donor advised fund. One of the Cru Foundation Gift Specialists can **help customize a giving plan** that aligns with your stewardship and generosity goals.

✔ GIFT OF ALL OR A PORTION OF YOUR LAND

If you own land with oil, gas or mineral rights, donating all or part of your land can produce a direct tax benefit while benefiting ministry. You will receive a charitable income tax deduction in the year you make your gift.

✔ GIFT OF ROYALTIES

If you don't need the income from your oil, gas or mineral rights or it is pushing you into the upper tax brackets with higher rates and fewer deductions, consider a gift of your royalties. You can lower your income and taxes while achieving your charitable goals.

✔ CHARITABLE REMAINDER TRUST

To maintain income while also maximizing charitable intent and charitable deductions, place your land into a charitable remainder unitrust. You will receive payments for your life or a term of up to 20 years and an income tax charitable deduction. Your favorite Cru ministries or missionaries will benefit from the remaining value.
